METRODORA Meaningful Engagement of Women in HIV Treatment Research

Women represent 29% of new diagnoses of HIV in Western Europe but 46% in Eastern Europe in ages 15-24

Less than a quarter of people taking part in clinical trials for antiretroviral medications are women

Treatment guidelines containing minimal advice on the care of women living with HIV and lack understanding on their response to medications



Project aim: to strengthen the meaningful and sustainable involvement of women in HIV R&D and to optimize engagement of women in clinical decision-making processes by educating women about gender-based differences and promoting **collaborative efforts with key stakeholders to address prevention and treatment regimens aligned to the needs of women living with or at risk of HIV.**

Objective 1: Women Engagement in HIV R&D : Assessment and Community based recommendations

Main Activities:
Mapping involvement of women in HIV R&D (identification of gaps, obstacles, unmet needs and best practices)
